The envelopes containing the "**Technical & Commercial Offer**" will be opened at 15.30 hrs on 12<sup>th</sup> February, 2019 at the office of the Vice-President (Management Services), Corporate Office, SBI Life Insurance Co Ltd, "Natraj Ground Floor, M V Road & Western Express Highway Junction, Andheri (E) Mumbai-400069.

SBI Life can reject any tender without giving any reason thereof and its decision will be final.

The selection of the supplier shall be at the sole discretion of SBI Life and no correspondence shall be entertained in this regard.

The tenders received after opening of the tender box, i.e. after 15.00 hours on 8<sup>th</sup> February, 2019 will be rejected.

#### 1. Other Terms & Conditions

a) SBI Life may accept or reject any or all the offers in part or in full irrespective of their being the lowest.

b) SBI Life may not require certain category of resources/services though the bidder should submit the bid for all the categories of resources /services as required under this bid.

c) SBI Life reserves the right to relax the tender conditions at any stage if considered necessary for the purpose of finalizing the contract in the overall interest of SBI Life.

d) SBI Life reserves the right to retender or negotiate with the lowest tenderer as regards the rates, terms and conditions of the tender, if deemed necessary.

e) SBI Life reserves the right to disqualify the Tenderer blacklisted by State/Central Govt. undertakings/Public Sector Units/ SBIG or whose contracts have been terminated by SBI Life on account of poor performance, if any such information comes to the knowledge of SBI Life at any stage either during the tendering process or after short listing the bidder.

f) The tenderer is requested to peruse the tender documents carefully so as to avoid rejection of the tender for non-compliance with the necessary instructions or with terms and conditions.

g) The tenderer is requested to ensure that the offers are submitted after full consideration and understanding of the work envisaged under this contract. The bid once submitted shall be final and cannot be altered. Only one bid from each participant shall be accepted. #### 3. <u>Tender Instructions.</u>

First sealed envelope should contain.

(a) Declaration by the tenderer on company letterhead as per format given in tender document.

(b) Copy of registration certificate (shop & establishments) set duly attested by competent authority.

(c) Copy of GST registration certificate duly attested by competent authority.

(d) Copies of work orders for supply of electrical materials duly attested by competent authority.

(e) Company profile.

(f) Original Tender Document duly signed and sealed on each page.

(g) Second sealed envelope should contain the Price Bid only. It should be subscribed as "Commercial Bid".

(h) The tender price will be exclusive of all taxes, transportation, loading, un-loading etc. The tenderer will be totally responsible for complying with all rules and requirements concerning all taxes and duties.

(i) The tendering firm / company should be registered under the relevant statutes by the relevant/ competent authority. The firm must attach an attested copy of the registration certificate and Partnership Deed / Memorandum of Association as the case may be.

(j) Period of validity of the tender is one month.

(k) This allotment of work shall be for period of two years on fixed discounted rate on MRP from the date of signing the rate agreement.

(I) The tenderer shall have to comply with all the rules, regulations, and laws .SBI Life, shall have no liability in this regard.

(m) The contractor/supplier shall not, without the consent in writing of SBI Life, transfer, assign or submit the work under this contract or any substantial part thereof to any other party.

(n) In case of any dispute or difference between SBI Life and the tenderer in connection with this agreement except as to matters, the decision for which has been specifically provided, either party may forthwith give to the other notice in writing (30 days) of existence of such dispute or difference and the same shall be referred to the sole arbitration of the Sr Vice President-MS or a person nominated by him. This reference shall be governed by Indian Arbitration Act 1940 and the rules made there under. The award in such arbitration shall be final and binding on both the parties. Work under the agreement shall continue during the arbitration proceedings unless SBI Life or the arbitrator directs otherwise.

(o) SBI Life may give notice at any time in writing to the contractor either to stop the services altogether or reduce or cut it down.

(p) Notices, statements and other communications sent by SBI Life through registered post or fax to the tenderer at his specified address shall be deemed to have been delivered to the supplier.

(q) No price escalation will be granted during the contract period.

(r) The bills must be submitted along with the signed delivery challans for payment.

(s) Rates quoted in the tender shall be valid till the entire completion period of the contract (Two Year) from date of Agreement

#### 4. <u>Services/ Delivery Terms</u>

a) If after the supply of delivered goods, it is discovered that the materials supplied are not according to our specifications/quality stipulated, such supply will be rejected at the suppliers cost.

b) In case of failure/delay in supply fully or partially, SBIL has liberty to get the same material through other source at its sole discretion and the difference in cost if any will be recoverable from defaulting party.

c) If the material supplied is found to be defective or date expired the same should be replaced free of cost. If the materials supplied by vendor are found to be duplicate, the vendor will be issued a showcause notice and shall be blacklisted.

#### 5. <u>Payment Terms</u>

a) 100% payment will be made on delivery and submission of invoice along with delivery challan within 14 working days subject to deduction of penalty. Further all payment shall be made subject to deduction of necessary taxes.

b) In case of products which are fake, duplicate, faulty or unsatisfactory the payment will not be done and rejected material shall be returned forthwith.

c) No advance payment shall be made.

#### 6. <u>Jurisdiction & Arbitration</u>

a) In case of dispute or any difference arising at any time between the parties in respect of this agreement, the same shall be resolved by mutual discussion and if not resolved, it shall be dealt with in accordance with and subject to be provision of the Indian Arbitration Act. Court of Mumbai shall have jurisdiction in all matters arising out of/ connected with this agreement. Further this agreement is subject to laws of India only.

**7.** <u>**Termination of Contract</u>** Either party can terminate the contract with thirty days (30) notice period in writing for non performance of any of the articles of the contract.</u>
