मुंबई : संजय गांधी राष्ट्रीय उद्यानाचा भाग असलेल्या येऊरमध्ये बांधण्यात आलेल्या टर्फ क्लबसह काही बेकायदा व्यावसायिक आस्थापनांवर कारवाई करण्याची जबाबदारी ही आमची नसून महापालिकेची आहे, असा दावा राज्य प्रदूषण नियंत्रण मंडळाने (एमपीसीबी) उच्च न्यायालयात केला. राष्ट्रीय उद्यानाच्या जागेवर टर्फ क्लबसह महालय, हॉटेल बांधण्यासाठी कोणतीही परवानगी

देण्यात आली नसल्याचेही एमपीसीबीने उच्च न्यायालयात दाखल केलेल्या प्रतिज्ञापत्रात म्हटले आहे. महापालिकेच्या परवानगीविना येऊरमध्ये टर्फ क्लबसह काही व्यावसायिक आस्थापनांची बांधकामे करण्यात आली आहेत. असे असतानाही, टाणे महापालिकेतर्फे त्याकडे डोळेझाक केली जात असल्याचा आरोप करणारी जनहित याचिका ठाणेस्थित रोहित जोशी यांनी केली आहे. येऊरमधील ही बांधकामे बेकायदा असल्याची कबुली महापालिकेनेही
