Pursuant to Regulation 30 read with Para A(7) of Part A of Schedule III of the SEBI (Listing Obligations & Disclosure Requirements) Regulation, 2015 ("Listing Regulation") and other applicable requirements, we wish to inform you that on basis of recommendation of the Board Nomination and Remuneration Committee, the Board of Directors vide Circular resolution on July 23, 2024, has approved the re-appointment of Ms. Usha Sangwan (DIN: 02609263) as an Independent Director not liable to retire by rotation. Her second term is subject to approval of the members and will be for a period of 3 (three) consecutive years commencing from August 24, 2024 and ending on August 23, 2027.

The details required under Regulation 30 of the Listing Regulations read with SEBI Circular No.: SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 are given in the enclosed Annexure A. Further, we confirm that Ms. Usha Sangwan is not debarred from holding the office of Director pursuant to any SEBI order or any other such authority as per the circular of the BSE Limited and the National Stock Exchange of India Limited relating to the Enforcement of SEBI orders regarding appointment of Directors by the listed companies dated June 20, 2018.

Further, we would like to inform you that the Board of Directors of the Company on July 23, 2024, through Circular Resolution, have inter alia, also agreed that Members' approval be sought through Postal Ballot, an item of Special Business pertaining to Re-appointment of Ms. Usha Sangwan (DIN: 02609263), as an Independent Director of the Company.

The Notice of Postal Ballot shall be circulated on Wednesday, July 24, 2024, through electronic mode to all Members whose names appear on the Register of Members maintained by National Securities Depository Limited / Central Depository Services (India) Limited/ the Registrar and Share Transfer Agent, as the case may be, as on Friday, July 12, 2024 (Cut-off Date). The e-Voting period will commence from 09:00 A.M. (IST) on Thursday, July 25, 2024 and shall end at 05:00 P.M. (IST) on Friday, August 23, 2024.
