This is your policy booklet containing the various terms and conditions governing your policy. This policy booklet should be read in conjunction with the policy schedule and other related documents of your policy.

If you find any errors, please return the policy for effecting corrections

1 Definitions

These definitions apply throughout your policy document.

The definitions are listed alphabetically.

Expressions	Meanings
1. Age	is the age last birthday; i.e., the age in completed years.
2. Age at entry	is the age last birthday on the date of commencement of your policy
3. Annuitant	is the person entitled to receive the annuity payout. The First Annuitant will be the First person entitled to receive the payouts, while the Second Annuitant will be entitled to receive the annuities, if so opted, in the event of death of the First Annuitant, if applicable.
4. Annuity installment	is the amount payable to the annuitant as per the frequency chosen by you.
5. Annuity Payment frequency	is the frequency as chosen by you at which the annuity amount will be payable. The frequency chosen may be yearly, half-yearly, quarterly or monthly.
6. Appointee	is the person who is so named in the proposal form or subsequently changed by endorsement, who has the right to give a valid discharge to the policy monies in case of the death of the annuitant, while the annuities are in payment, when the nominee is a minor.
7. Assignee	is the person to whom the rights and benefits are transferred by virtue of an assignment under section 38 of the Insurance Act, 1938, as amended from time to time.
8. Base Policy	is that part of your Policy referring to basic benefit.
9. Beneficiary	means persons nominated by the policy owner to receive the death benefits under the provision of your policy. The Beneficiary maybe you, or the nominee or the assignee or the legal heirs as the case may be. The beneficiary may be stated in the policy schedule or may be changed or added subsequently.
10. Birthday	is the conventional Birthday. If it is on 29th February, it will be considered as falling on the last day of February.
11. Date of Commencement of Annuity	is the date of payment of Initial Annuity installment.
12. Date of Commencement of Policy	is the start date of your policy.
13. Death Benefit	is the amount, if any, payable on death of the annuitant, to the beneficiary as stated in the policy document.
14. Deferment period	is a fixed period from the date of commencement of policy till the date on which the first annuity payment is due and payable to the annuitant as per the terms and conditions as specified in the policy document.
15. Endorsement	a change in any of the terms and conditions of your policy, agreed to or issued by us, in writing.
16. Free-look period	is the period during which the policyholder has the option to return the policy and cancel the contract.
17. Initial Annuity installment	is the first annuity amount payable to the Annuitant.
18. Instrument	cheque, demand draft, pay order etc.
19. Legal Heir	means the person(s) legally eligible to receive the insurance benefits under the provisions of the policy in case the Nominee is not surviving or there is invalid nomination.
20. Minor	is a person who has not completed 18 years of age.
21. Nominee	is the person who is named as the Nominee in the proposal form or subsequently changed by an Endorsement, as per Section 39 of the Insurance Act, 1938, who has the right to give a valid

	discharge to the policy monies in case of the death of the Annuitant, while the annuities are in payment, if such nomination is not disputed.
22. Policyholder or Policy Owner	is the owner of the policy and is referred to as the proposer in the proposal form. The policy owner need not necessarily be the same person as the annuitant.
23. Policy Anniversary	is the same date on each subsequent year as the date of commencement. If the date of commencement is on 29th of February, the policy anniversary will be the last date of February.
24. Policy document	means the policy schedule, policy booklet, endorsements (if any),. Any subsequent written agreements (if any) mutually agreed by you and us during the term of the policy also forms a part of the Policy document.
25. Policy Schedule	is the document that sets out the details of your policy.
26. Policy Year	is the period between two consecutive Policy Anniversaries. This period includes the first day of the Policy year and excludes the next policy anniversary day.
27. Premium / Purchase Price	is the contractual amount payable by the Policyholder in order to secure the benefit under the provisions of your policy. Taxes and other statutory levies, as applicable, would be payable in addition to the premium.
28. Product conversion	Means purchasing annuities by the amount vesting under the SBI Life pension product in consideration of the accumulated funds / corpus / amount which is also referred as Compulsory Purchase Annuity amount (CPA).
29. Survival Benefit	refers to the contractual payments we would make on the survival of the annuitant/s, in accordance with the terms and conditions of the policy.
30. You, Your	is the person named as the policyholder.
31. We, Us, Our	SBI Life Insurance Company Limited or its successors. We are regulated by the Insurance Regulatory and Development Authority of India (IRDAI). The registration number allotted by the IRDAI is 111.

3 Base Policy Benefits Under Annuity Options

The annuity option exercised by you is final and cannot be altered.

Single Life Options:**3.1 Option 1.1: Life Annuity:**

- 3.1.1 **Survival Benefit:** We will pay the annuity installment as long as the annuitant is alive. The annuity installment will remain at the same level.
- 3.1.2 **Death Benefit:** There is no benefit payable on death. Annuity payments would cease immediately on the death of the Annuitant.
- 3.1.3 **Termination:** The policy will terminate on death of the annuitant and no further benefits shall be payable under the policy.

3.2 Option 1.2: Life Annuity with Return of Purchase Price:

- 3.2.1 **Survival Benefit:** We will pay the annuity installment as long as the annuitant is alive. The annuity installment will remain at the same level.
- 3.2.2 **Death Benefit:** On death of the annuitant, we will refund the purchase price paid under the base product to the nominee or beneficiary, as the case may be. Annuity payments will cease immediately from the date of death of the Annuitant.
- 3.2.3 **Termination:** The policy will terminate immediately on death of the annuitant.

3.3 Option 1.3: Life Annuity with Return of Balance Purchase Price:

- 3.3.1 **Survival Benefit:** We will pay the annuity installment as long as the annuitant is alive. The annuity installment will remain at the same level.
- 3.3.2 **Death Benefit:** On death of the annuitant, we will refund the balance purchase price, if any, to the nominee or beneficiary, as the case may be.
 - 3.3.2.1 This balance purchase price will be equal to the purchase price received under the base product less sum total of all the annuity installments already received by the annuitant, if any. Further annuity payments will cease immediately from the date of death of the Annuitant.
 - 3.3.2.2 If this balance is not positive, then no death benefit is payable. That is, if the total amount of annuities paid till the date of death exceeds the purchase price received, then no death benefit shall be payable.
- 3.3.3 **Termination:** The policy will terminate immediately on the death of the annuitant.

3.4 Option 1.4: Life Annuity with Annual Simple Increase of 3%:

- 3.4.1 **Survival Benefit:** We will pay the annuity installment as long as the annuitant is alive. The installment amount will be increased by a simple rate of 3% per annum for each completed policy year.
- 3.4.2 **Death Benefit:** There is no further benefit payable on death. Annuity payments will cease immediately from the date of death of the Annuitant.
- 3.4.3 **Termination:** The policy will terminate immediately on death of the annuitant.

3.5 Option 1.5: Life Annuity with Annual Simple Increase of 5%:

- 3.5.1 **Survival Benefit:** We will pay the annuity installment as long as the annuitant is alive. The installment amount will be increased by at a simple rate of 5% per annum for each completed policy year.
- 3.5.2 **Death Benefit:** There is no further benefit payable on death. annuity payments will cease immediately from the date of death of the annuitant.
- 3.5.3 **Termination:** The policy will terminate immediately on the death of the annuitant.

3.6 Option 1.6: Life Annuity with Certain Period of 10 years:

- 3.6.1. **Survival Benefit:** We shall pay the annuity installments during the first 10 policy years irrespective of whether the annuitant is alive or not. The annuity installment will remain at the same level.
- 3.6.1.1. After completion of first 10 policy years we will continue to pay the annuity installments as long as the annuitant is alive. The annuity installment will remain at the same level.
- 3.6.2. **Death Benefit:** There is no benefit payable on death if the Annuitant dies after completion of 10 years from the date of commencement of policy. Annuity payments will cease immediately from the date of death of the Annuitant.
- 3.6.2.1. If the Annuitant dies before completion of 10 years from the date of commencement of the policy, the annuities will continue to be paid only for the balance period of the first 10 years from the date of commencement of the policy and thereafter the annuities shall cease and no further benefit shall be payable on death of the Annuitant.
- 3.6.3. **Termination:** The policy will terminate immediately on the death of the annuitant or on the completion of 10 policy years from the date of commencement of the policy, whichever is later.

3.7 Option 1.7: Life Annuity with Certain Period of 20 years:

- 3.7.1. **Survival Benefit:** We shall pay the annuity installments during the first 20 policy years irrespective of whether the annuitant is alive or not. The annuity installment will remain at the same level.
- 3.7.1.1. After completion of first 20 policy years we will continue to pay the annuity installments thereafter as long as the annuitant is alive. The annuity installment will remain at the same level.
- 3.7.2. **Death Benefit:** There is no benefit payable on death if the Annuitant dies after completion of 20 years from the date of commencement of the policy. Annuity payments will cease immediately from the date of death of the Annuitant.
- 3.7.2.1. If the Annuitant dies before completion of 20 years from the date of commencement of the policy, the annuities will continue to be paid only for the balance period of the first 20 years from the date of commencement of the policy and thereafter the annuities shall cease and no further benefit shall be payable on death of the Annuitant.
- 3.7.3. **Termination:** The policy will terminate immediately on the death of the annuitant or on the completion of 20 policy years from the date of commencement of policy, whichever is later.

3.8 Option 1.8: Life Annuity with Annual Compound Increase of 3%:

- 3.8.1. **Survival Benefit:** We will pay the annuity installment as long as the annuitant is alive. The installment amount will be increased by a compound rate of 3% per annum for each completed policy year.
- 3.8.2. **Death Benefit:** There is no benefit payable on death of the Annuitant. annuity payments will cease immediately from the date of death of the Annuitant.
- 3.8.3. **Termination:** The policy will terminate immediately on death of the annuitant and no further benefits shall be payable under the policy.

3.9 Option 1.9: Life Annuity with Annual Compound Increase of 5%:

- 3.9.1. **Survival Benefit:** We will pay the annuity installment as long as the annuitant is alive. The installment amount will be increased by a compound rate of 5% per annum for each completed policy year.
- 3.9.2. **Death Benefit:** There is no benefit payable on death of the Annuitant. Future annuity payments will cease immediately from the date of death of the annuitant.
- 3.9.3. **Termination:** The policy will terminate immediately on death of the annuitant and no further benefits shall be payable under the policy.

3.10 Option 1.10: Deferred Life Annuity with Return of Purchase Price:

- 3.10.1. **Survival Benefit:** We will pay the annuity installment as long as the annuitant is alive after the end of the deferment period. The annuity installment will remain at the same level. The deferment period is as opted by you and mentioned in the Policy schedule above on page no. 10 in point 37
- 3.10.2. **Death Benefit:**
- 3.10.2.1. On death of the annuitant during the deferment period, the death benefit payable to the nominee or the legal heir, as the case may be, shall be higher of:
- 3.10.2.1.1. 100% of Purchase Price + Guaranteed Additions accrued till date of death, OR
- 3.10.2.1.2. 105% of Purchase Price

- 3.10.2.2. On death of the annuitant after the deferment period: the death benefit payable to the nominee or the legal heir, as the case may be, shall be higher of:
- 3.10.2.2.1. 100% of Purchase Price + Guaranteed Additions accrued during the deferment period – Total Annuity paid out till date of death of annuitant, OR
- 3.10.2.2.2. 100% of Purchase Price
- Where Guaranteed additions per month = Total Annuity payable in a policy year/12.*
Guaranteed Additions accrue at the end of every policy month during the deferment period.
- 3.10.3. **Termination:** The policy will terminate immediately on death of the annuitant and all future benefits / annuity payments cease immediately.

Joint Life Options:

3.11 Option 2.1: Life and Last Survivor – 100% Annuity:

- 3.11.1. **Survival Benefit:** We will pay the annuity installment, as long as either of the annuitants are alive. The annuity installment will remain at the same level.
- 3.11.2. **Death Benefit:**
- 3.11.2.1. On death of the First annuitant, if the Second annuitant is alive we will continue to pay the annuity installments throughout the life of the surviving Second annuitant. On subsequent death of the Second annuitant, annuity payments will cease immediately from the date of death of the second annuitant.
- 3.11.2.2. On death of the Second annuitant if the First annuitant is alive, we shall continue to pay the annuity installment throughout the life of the surviving First annuitant. On subsequent death of the First annuitant, all annuity payments would cease immediately from the date of death of the First Annuitant.
- 3.11.3. **Termination:** The policy will terminate immediately on the death of the last surviving annuitant and no further benefits shall be payable under the policy.

3.12 Option 2.2: Life and Last Survivor – 100% Annuity with Return of Purchase Price:

- 3.12.1. **Survival Benefit:** We will pay the annuity installment, as long as either of the annuitants is alive. The annuity installment will remain at the same level.
- 3.12.2. **Death Benefit:**
- 3.12.2.1. On death of the First annuitant if the Second annuitant is alive, we shall continue to pay the annuity installments throughout the life of the surviving Second annuitant. On subsequent death of the Second annuitant, we will refund the purchase price paid under the base policy to the nominee or the legal heir, as the case may be. Further annuity payments will cease immediately date of death of the Second annuitant.
- 3.12.2.2. On death of the Second annuitant if the First annuitant is alive, we shall continue to pay the annuity installment throughout the life of the surviving First annuitant. On subsequent death of the First annuitant, we will refund the purchase price paid under the base policy to the nominee or the legal heir, as the case may be, annuity payments cease immediately from the date of death of the First Annuitant.
- 3.12.3. **Termination:** The policy will terminate immediately on the death of the last surviving annuitant.

3.13 Option 2.3: Deferred Life & Last Survivor Annuity with Return of Purchase Price.

- 3.13.1. **Survival Benefit:** We will pay the annuity installment as long as either of the annuitants is alive after the end of the deferment period. The annuity installment will remain at the same level. The deferment period is as opted by you and mentioned in the Policy schedule above in point 37
- 3.13.2. **Death Benefit:**
- 3.13.2.1. On death of the last survivor during the deferment period, the death benefit payable to the nominee or the legal heir, as the case may be, shall be higher of:
- 3.13.2.1.1. 100% of Purchase Price + Guaranteed Additions accrued till date of death, OR
- 3.13.2.1.2. 105% of Purchase Price
- 3.13.2.2. On death of the last survivor after the deferment period, the death benefit payable to the nominee or the legal heir, as the case may be, shall be higher of:
- 3.13.2.2.1. 100% of Purchase Price + Guaranteed Additions accrued during the deferment period – Total Annuity paid out till date of death of last survivor, OR
- 3.13.2.2.2. 100% of Purchase Price
- Where Guaranteed additions per month = Total Annuity payable in a policy year/12.*
Guaranteed Additions accrue at the end of every policy month during the deferment period only.

- 3.13.3. **Termination:** The policy will terminate immediately on death of the last survivor and all future benefits / annuity payments shall cease immediately from the date of death of the last survivor.

3.14 Option 2.4: NPS - Family Income:

- 3.14.1. The annuity benefits under this option would be payable in accordance with the regulations as prescribed by PFRDA.
- 3.14.2. As per the current regulations, the annuity benefits will be payable for life of the subscriber and his/her spouse as per the annuity option either “Life Annuity with Return of Purchase Price” Or “Life and Last Survivor – 100% Annuity with Return of Purchase Price” as the case may be.
- 3.14.3. In case the subscriber does not have a spouse, the annuity benefits will be payable for life of the subscriber as per the annuity option “Life Annuity with Return of Purchase Price”.
- 3.14.4. In case the subscriber has a spouse, the annuity benefits will be payable for life of the subscriber as per the annuity option “Life and Last Survivor – 100% Annuity with Return of Purchase Price”.
- 3.14.5. On death of the annuitant(s) or both the annuitants, as the case may be, the annuity payment would cease and the refund of purchase price shall be utilized to purchase an annuity contract afresh for living dependent parents (if any) as per the order specified below:
- a. Living dependent mother of the deceased subscriber;
 - b. Living dependent father of the deceased subscriber.
- 3.14.5.1. The annuity amount would be revised and determined as per the annuity option “Life Annuity with Return of Purchase Price” using the annuity rate prevalent at the time of purchase of such annuity by utilizing the premium required to be refunded to the nominee under the annuity contract.
- 3.14.5.2. The annuity would continue until all such family members in the order specified above are covered.
- 3.14.5.3. After the coverage of all such family members, the purchase price shall be refunded to the surviving children of the subscriber and in the absence of children, the legal heirs of the subscriber, as may be applicable.
- 3.14.5.4. In case no such family member exists upon the death of the last survivor, there would be a refund of purchase price to the nominee.
- 3.14.6. In case of demise of the subscriber, the annuity benefits will be payable for life of the spouse, if any, as per the annuity option “Life Annuity with Return of Purchase Price”.

4 Guaranteed Addition

- 4.1 Guaranteed additions are payable under deferred annuity options.
- 4.2 Guaranteed additions will accrue at the end of every policy month during deferment period only.
- 4.3 Guaranteed addition per month is equal to total annuity payable in a policy year divided by 12.
- 4.4 *The total annuity payable in a policy year would be the annualized annuity rates payable per month without applying any modal factors.*
- 4.5 Accrued guaranteed additions would be payable in case of death of the Annuitant or/ surrender of the policy only in case of deferred annuity as mentioned in the respective annuity options in this document.

5 Premium

- 5.1 The Premium or Purchase Price is required to be paid only once at inception.
- 5.2 The Premium or Purchase Price refers to the amount received / to be received from the proposer/ first annuitant exclusively for the purchase of the annuity.
- 5.3 The Premium or Purchase Price does not include applicable taxes and other statutory levies.
- 5.4 The amount in respect of applicable taxes and statutory levies is charged in additions to the premium, at the rate notified by the Government of India / Tax Authorities from time to time.
- 5.5 If we receive any amount in excess of the required premium, we will refund the excess. We will not pay any interest on this excess amount.

6 Claims

6.1 Annuity Benefit:

- 6.1.1. Annuity benefits payable to annuitant (s) depending upon:
 - 6.1.1.1. Annuitant(s) Age at entry,
 - 6.1.1.2. Annuity Option chosen by the annuitant,
 - 6.1.1.3. Annuity Payment Frequency chosen by the annuitant,
 - 6.1.1.4. Annuity Rates prevailing at the time of purchase of the annuity, and
 - 6.1.1.5. Purchase Price / Premium paid by the annuitant.
- 6.1.2. You cannot change the Annuity Payment Frequency once an option is exercised.
- 6.1.3. You will be liable to pay all applicable taxes as levied by the Government and other Statutory Authorities on the annuity payouts or any other policy benefits.
- 6.1.4. All Applicable Taxes shall be deducted at source as per the Income Tax Rules as amended from time to time.

6.2 Death Benefit:

- 6.2.1. The policyholder, nominee or the legal heir should intimate the death of the annuitant in writing, stating at least the policy number, cause of death and date of death.
- 6.2.2. Depending on the annuity option, we shall pay annuity to the second annuitant on the death of the first annuitant, if such a benefit is payable under the option chosen or
- 6.2.3. Depending on the annuity option, we shall pay the death claim, if any, to the nominee, legal heir or to your estate if such a benefit is payable under the option chosen.
- 6.2.4. In case of death of the annuitant, proportional annuity amount, if any would be payable for the period between the date of last annuity paid and the date of death of the annuitant.
- 6.2.5. If the date of death is on the due date of annuity installment, then due annuity installment amount would be paid.
- 6.2.6. We will require the following documents to process the claim:
 - 6.2.6.1. Original policy document
 - 6.2.6.2. Original death certificate from municipal / local authorities
 - 6.2.6.3. Claimant's statement and claim forms in prescribed formats
 - 6.2.6.4. Any other document which SBI Life may call, if found necessary in support of the claim
- 6.2.7. Claim under the policy may be filed with us within 90 days of date of death.
- 6.2.8. However, without prejudice, in case of delay in intimation or submission of claim documents beyond the stipulated period in the policy document or in the Statutes, We, may condone such delay and examine the admissibility or otherwise of the claim, if such delay is proved to be for reasons beyond the control of the nominee/claimant. We would recover annuity installment(s) that have fallen due and paid after the date of death for the options where the annuity payment would cease on the death of the annuitant(s).
- 6.2.9. Please go through the policy document carefully to understand whether any death benefit is payable under the option chosen by the Annuitant under the policy because under certain options, there is no death benefit that shall be payable under the policy on the death of the Annuitant[s].

6.3 Surrender Benefit:

- 6.3.1. Surrender Value (SV) is available only under Deferred Annuity Options and Annuity Options with full Refund of Purchase Price.
- 6.3.2. The Surrender Value for deferred annuity within deferment period will be higher of:
 - 6.3.2.1. Guaranteed Surrender Value (GSV) which will be equal to GSV factor A multiplied by Purchase price plus GSV factor B multiplied by accrued guaranteed additions.
 - 6.3.2.2. Special Surrender Value (SSV) which will be equal to SSV factor A multiplied by (SSV factor B multiplied by Yearly Annuity plus SSV factor C multiplied by Purchase price)
Where SSV Factor B and SSV Factor C applicable will be basis the age of the policyholder immediately post completion of the deferment period.
- 6.3.3. The surrender value for immediate annuity with Return of Purchase Price and for deferred annuity post deferment period will be higher of

6.3.7. The methodology for computing the SSV factor may be reviewed from time to time.

6.3.8. Any change in Surrender Value (SV) calculation method shall only be after prior approval from IRDAI

6.4 Maturity Benefit

6.4.1. There is no maturity benefits under the policy

7 General Terms**7.1 Existence Certificate**

- 7.1.1. You are required to submit an Existence Certificate before the next annuity payment anniversary as per the frequency mentioned in the Policy Schedule in the format provided by us. We may review the frequency of submission of the Existence Certificate from time to time and any change in the same will be informed to the annuitant.
- 7.1.2. In case the existence certificate is not received, the annuity payments shall cease. The annuity payment shall however resume on receipt of the existence certificate and all the arrears will be settled without any interest.
- 7.1.3. In case of 'Life and Last Survivor' types, the Existence Certificate of the First annuitant will be required. After the death of the First Annuitant the Existence certificate of the Second annuitant will be required.

7.2 Free look Period

- 7.2.1. If you have purchased the policy through distance marketing channel and for electronic policies, you have 30 days from the date of receipt of this policy document to review its terms and conditions. If you are not satisfied, you can return the policy stating the reason for cancellation.
- 7.2.2. If you have purchased this policy through a channel other than distance marketing, you have 15 days from the date of the receipt of this policy document to review its terms and conditions. If you are not satisfied, you can return the policy stating the reasons for cancellation.
- 7.2.3. In case, you choose not to continue, we will then refund the premium paid less any annuity payouts already made less stamp duty paid.
- 7.2.4. If you have purchased this policy out of Product conversion (Corpus from vesting of your pension policy with us), we will not be able to refund the monies to you. However, you can change the annuity option during the free look cancellation period and continue the policy.
- 7.2.5. If you have purchased this policy out of Transfer proceeds or out of corpus from vesting of your pension policy from any other company, insurer or institution (including NPS),
 - 7.2.5.1. We will refund the monies directly to the employer or the trust or the entity (such as NPS) , provided that it is authorized to receive such amounts and is approved under the prevalent regulations.
 - 7.2.5.2. We will not pay you any interest on the monies held by us during this interim period.
- 7.2.6. You cannot revive, reinstate or restore your policy once you have returned your policy.
- 7.2.7. We will not pay any benefit under your policy after we receive the free-look cancellation request.

7.3. Access to benefits/payout if this product is purchased as QROPS (Qualifying Recognized Overseas Pension Scheme), through transfer of UK tax relieved assets

Notwithstanding anything stated under this document, the following terms & conditions shall apply to QROPS policyholders

- 7.3.1. Cancellation in the Free-Look Period - If this product is purchased as QROPS through transfer of UK tax relieved assets, the proceeds from cancellation in the free-look period shall only be transferred back to the fund house from where the money was received.
- 7.3.2. Non-Forfeiture Benefits – If this product is purchased as QROPS through transfer of UK tax relieved assets, access to benefits are restricted till the policyholder attains 55 years of age, hence the age at entry would be a minimum of 55 years of age or any such age as specified as per HMRC regulations.

7.4. Policy Loan

9 General Terms - Miscellaneous

9.1 Nomination

- 9.1.1. If you are the policyholder and the First annuitant, you may, when effecting the policy or at any time thereafter nominate a person or persons to whom the money secured by the policy shall be paid in the event of the death of the last surviving annuitant.
- 9.1.2. If the nominee is a minor, you may appoint a person, competent to contract, as an appointee in the manner laid down by us, to receive the money secured by the policy in the event of the death of the last surviving annuitant during the minority of the nominee.
- 9.1.3. You may cancel or change the existing nomination. On death of the First annuitant, the Second annuitant can change the existing nomination.
- 9.1.4. The nomination should be registered in our records so as to make it binding on us.
- 9.1.5. For complete details about the nomination, please refer to Section 39 of the Insurance Act, 1938 as amended from time to time.

[For the simplified version of the provisions of Section 39 please refer Annexure I]

9.2 Assignment

Assignment shall be as per Section 38 of the Insurance Act, 1938 as amended from time to time [Please refer Annexure III]

9.3 Non-disclosure

- 9.3.1 We have issued your policy based on your statements in the physical proposal form or electronic web based proposal form, as the case may be; personal statement, and any other documents that are submitted to us.
- 9.3.2 If we find that any of this information is inaccurate or false or you have withheld any material information, we will have a right cancel your policy as per the provisions of Section 45 of the Insurance Act 1938, as amended from time to time.

[A leaflet containing the simplified version of the provisions of Section 45 is enclosed in Annexure – III for reference]

9.4 Misstatement of age

If we find that the correct age of the annuitant(s) is different from that mentioned in the proposal form, we will check his/ her eligibility for the annuity payment as on the date of commencement.

9.4.1 If eligible, we shall use either of the following two processes:

- 9.4.1.1 If you have purchased this policy out of corpus from vesting of your pension policy with us,
- 9.4.1.1.1 We will re-calculate the annuity as at the date of purchase of annuity and alter it corresponding to the correct age of the annuitant. We will continue to pay the revised annuity subject to the following conditions:
- 9.4.1.1.2 If the revised annuity is found to be lower, you have to pay the difference, arising out of incorrect annuities paid in the past, along with interest at the then prevailing interest rate as specified by us from time to time.
- 9.4.1.1.3 If you do not refund the excess annuity amount along with applicable interest, we shall re-calculate annuity amount at the date of purchase of annuity, that is, at inception for the correct age and for the modified purchase price. The original purchase price will be modified in order to recover the excess annuity amount paid along with applicable interest.
- 9.4.1.1.4 If the revised annuity is found to be higher, we will pay the difference arising out of incorrect annuities paid in the past, to you or beneficiary, as the case may be, as a lump sum amount without any interest.

9.4.1.2 If you have purchased this policy from sources other than out of Corpus from vesting of your pension policy with us,

9.4.1.2.1 We will re-calculate the purchase price as at the date of purchase of annuity and alter it corresponding to the correct age of the annuitant. The purchase price will be re-calculated as at the date of purchase of annuity subject to the following conditions:

9.4.1.2.2 If the revised purchase price is found to be higher, you should pay the difference in purchase price along with interest as specified by us from time to time and taxes as applicable.

9.4.1.2.3 If you do not pay the difference in purchase price and applicable interest and taxes, we shall re-calculate the annuity amount as at the date of purchase of annuity for the correct age and for the modified purchase price. The original purchase price will be modified in order to recover the excess annuity amount paid along with applicable interest. We will then continue to pay revised annuity to the annuitant.

9.4.1.2.4 If the revised purchase price is found to be lower, we will recalculate the annuities based on your correct age and the actual purchase price received by us and pay the difference in the annuities arisen out of such correction, if any, in one lumpsum without any interest what so ever.

9.4.2 If not eligible,

9.4.2.1 We will terminate your policy. The benefits payable under this policy shall stand cancelled, and the purchase price paid (minus stamp duty and applicable taxes minus sum total of annuity installments made till date of cancellation) will be refunded to you or beneficiary, as the case may be, without interest.

9.5 Taxation

9.5.1 You are liable to pay the applicable taxes and/ or any other statutory levy/ duty/ surcharge on the basic premium and / or other charges (if any) as per product features; at a rate notified by the State Government or Central Government of India from time to time, as per the applicable tax laws.

11 Relevant Statutes

11.1 Governing laws and jurisdiction

This policy contract shall be governed by Indian Laws. Any dispute that may arise in connection with this shall be subject to the jurisdiction of the competent Courts of India ONLY.

11.2 Section 41 of the Insurance Act 1938 as amended from time to time

- (1) No person shall allow or offer to allow, either directly or indirectly, as an inducement to any person to take or renew or continue an insurance in respect of any kind of risk relating to lives or property in India, any rebate of the whole or part of the commission payable or any rebate of the premium shown on the policy, nor shall any person taking out or renewing or continuing a policy accept any rebate, except such rebate as may be allowed in accordance with the published prospectuses or tables of the insurer.
- (2) Any person making default in complying with the provisions of this section shall be liable for a penalty which may extend to ten lakh rupees

11.3 Section 45 of the Insurance Act 1938 as amended from time to time

[For the simplified version of the provisions of Section 45 please refer Annexure – II]

11.4 Rule 13 of Ombudsman Rules, 2017

1. The Ombudsman may receive and consider complaints or disputes relating to:
 - a) delay in settlement of claims, beyond the time specified in the regulations, framed under the Insurance Regulatory and Development Authority of India Act, 1999;
 - b) any partial or total repudiation of claims by the life insurer, General insurer or the health insurer;
 - c) disputes over premium paid or payable in terms of insurance policy;
 - d) misrepresentation of policy terms and conditions at any time in the policy document or policy contract;
 - e) legal construction of insurance policies in so far as the dispute relates to claim;
 - f) policy servicing related grievances against insurers and their agents and intermediaries;
 - g) issuance of life insurance policy, general insurance policy including health insurance policy which is not in conformity with the proposal form submitted by the proposer;
 - h) non-issuance of insurance policy after receipt of premium in life insurance and general insurance including health insurance; and
 - i) any other matter resulting from the violation of provisions of the Insurance Act, 1938, as amended from time to time, or the regulations, circulars, guidelines or instructions issued by the IRDAI from time to time or the terms and conditions of the policy contract, in so far as they relate to issues mentioned at clauses (a) to (f) .
2. The Ombudsman shall act as counsellor and mediator relating to matters specified in sub-rule (1) provided there is written consent of the parties to the dispute.
3. The Ombudsman shall be precluded from handling any matter if he is an interested party or having conflict of interest.
4. The Central Government or as the case may be, the IRDAI may, at any time refer any complaint or dispute relating to insurance matters specified in sub-rule (1), to the Insurance Ombudsman and such complaint or dispute shall be entertained by the Insurance Ombudsman and be dealt with as if it is a complaint made under Rule 14.

11.5 Rule 14 of Ombudsman Rules, 2017

- (1) Any person who has a grievance against an insurer, may himself or through his legal heirs, nominee or assignee, make a complaint in writing to the Insurance Ombudsman within whose territorial jurisdiction the branch or office of the insurer complained against or the residential address or place of residence of the complainant is located.
- (2) The complaint shall be in writing, duly signed by the complainant or through his legal heirs, nominee or assignee and shall state clearly the name and address of the complainant, the name of the branch or office of the insurer against whom the complaint is made, the facts giving rise to complaint, supported by documents, the nature and extent of the loss caused to the complainant and the relief sought from the Insurance Ombudsman.

- (3) No complaint to the Ombudsman shall lie unless –
 - a) The complainant makes a written representation to the insurer named in the complaint and
 - a. Either the insurer had rejected the complaint; or
 - b. the complainant had not received any reply within a period of one month after the insurer received his representation; or
 - c. the complainant is not satisfied with the reply given to him by the insurer
 - b) the complaint is made within one year
 - a. after the order of the insurer rejecting the representation is received; or
 - b. after receipt of decision of the insurer which is not to the satisfaction of the complainant;
 - c. after expiry of a period of one month from the date of sending the written representation to the insurer if the insurer named fails to furnish reply to the complainant
- (4) The Ombudsman shall be empowered to condone the delay in such cases as he may consider necessary, after calling for objections of the insurer against the proposed condonation and after recording reasons for condoning the delay and in case the delay is condoned, the date of condonation of delay shall be deemed to be the date of filing of the complaint, for further proceedings under these rules.
- (5) No complaint before the Insurance Ombudsman shall be maintainable on the same subject matter on which proceedings are pending before or disposed of by any court or consumer forum or arbitrator.

11.6 Protection of Policyholders’ Interest

The IRDAI (Protection of Policyholders’ Interest) Regulation, 2017 for protection of interests of the policyholders. The provisions of these regulations will be applicable and subject to the prevailing law, as amended from time to time.

Annexure-I

Section 39 - Nomination by policyholder

Nomination of a life insurance Policy is as below in accordance with Section 39 of the Insurance Act, 1938, as amended by Insurance Laws (Amendment) Act, 2015. The extant provisions in this regard are as follows:

1. The policyholder of a life insurance on his own life may nominate a person or persons to whom money secured by the policy shall be paid in the event of his death.
2. Where the nominee is a minor, the policyholder may appoint any person to receive the money secured by the policy in the event of policyholder's death during the minority of the nominee. The manner of appointment to be laid down by the insurer.
3. Nomination can be made at any time before the maturity of the policy.
4. Nomination may be incorporated in the text of the policy itself or may be endorsed on the policy communicated to the insurer and can be registered by the insurer in the records relating to the policy.
5. Nomination can be cancelled or changed at any time before policy matures, by an endorsement or a further endorsement or a will as the case may be.
6. A notice in writing of Change or Cancellation of nomination must be delivered to the insurer for the insurer to be liable to such nominee. Otherwise, insurer will not be liable if a bonafide payment is made to the person named in the text of the policy or in the registered records of the insurer.
7. Fee to be paid to the insurer for registering change or cancellation of a nomination can be specified by the Authority through Regulations.
8. On receipt of notice with fee, the insurer should grant a written acknowledgement to the policyholder of having registered a nomination or cancellation or change thereof.
9. A transfer or assignment made in accordance with Section 38 shall automatically cancel the nomination except in case of assignment to the insurer or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the nomination will not get cancelled to the extent of insurer's or transferee's or assignee's interest in the policy. The nomination will get revived on repayment of the loan.
10. The right of any creditor to be paid out of the proceeds of any policy of life insurance shall not be affected by the nomination.
11. In case of nomination by policyholder whose life is insured, if the nominees die before the policyholder, the proceeds are payable to policyholder or his heirs or legal representatives or holder of succession certificate.
12. In case nominee(s) survive the person whose life is insured, the amount secured by the policy shall be paid to such survivor(s).
13. Where the policyholder whose life is insured nominates his
 - a. parents or
 - b. spouse or
 - c. children or
 - d. spouse and children
 - e. or any of them

the nominees are beneficially entitled to the amount payable by the insurer to the policyholder unless it is proved that policyholder could not have conferred such beneficial title on the nominee having regard to the nature of his title.

14. If nominee(s) die after the policyholder but before his share of the amount secured under the policy is paid, the share of the expired nominee(s) shall be payable to the heirs or legal representative of the nominee or holder of succession certificate of such nominee(s).
15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance policies maturing for payment after the commencement of Insurance Laws (Amendment) Ordinance, 2014 (i.e. 26.12.2014).
16. If policyholder dies after maturity but the proceeds and benefit of the policy has not been paid to him because of his death, his nominee(s) shall be entitled to the proceeds and benefit of the policy.
17. The provisions of Section 39 are not applicable to any life insurance policy to which Section 6 of Married Women's Property Act, 1874 applies or has at any time applied except where before or after Insurance Laws (Ordinance) 2014, a nomination is made in favour of spouse or children or spouse and children whether or not on the face of the policy it is mentioned that it is made under Section 39. Where nomination is intended to be made to spouse or children or spouse and children under Section 6 of MWP Act, it should be specifically mentioned on the policy. In such a case only, the provisions of Section 39 will not apply.

Annexure-II

Section 45 – Policy shall not be called in question on the ground of mis-statement after three years

Provisions regarding policy not being called into question in terms of Section 45 of the Insurance Act, 1938, as amended by Insurance Laws (Amendment) Act, 2015 are as follows:

1. No Policy of Life Insurance shall be called in question **on any ground whatsoever** after expiry of 3 yrs from
 - a. the date of issuance of policy or
 - b. the date of commencement of risk or
 - c. the date of revival of policy or
 - d. the date of rider to the policy
whichever is later.
2. On the ground of fraud, a policy of Life Insurance may be called in question within 3 years from
 - a. the date of issuance of policy or
 - b. the date of commencement of risk or
 - c. the date of revival of policy or
 - d. the date of rider to the policy
whichever is later.

For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which such decision is based.

3. Fraud means any of the following acts committed by insured or by his agent, with the intent to deceive the insurer or to induce the insurer to issue a life insurance policy:
 - a. The suggestion, as a fact of that which is not true and which the insured does not believe to be true;
 - b. The active concealment of a fact by the insured having knowledge or belief of the fact;
 - c. Any other act fitted to deceive; and
 - d. Any such act or omission as the law specifically declares to be fraudulent.
4. Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the insured or his agent keeping silence to speak or silence is in itself equivalent to speak.
5. No Insurer shall repudiate a life insurance Policy on the ground of Fraud, if the Insured / beneficiary can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress the fact or that such mis-statement of or suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the policyholder, if alive, or beneficiaries.
6. Life insurance Policy can be called in question within 3 years on the ground that any statement of or suppression of a fact material to expectancy of life of the insured was incorrectly made in the proposal or other document basis which policy was issued or revived or rider issued. For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which decision to repudiate the policy of life insurance is based.
7. In case repudiation is on ground of mis-statement and not on fraud, the premium collected on policy till the date of repudiation shall be paid to the insured or legal representative or nominee or assignees of insured, within a period of 90 days from the date of repudiation.
8. Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the insurer. The onus is on insurer to show that if the insurer had been aware of the said fact, no life insurance policy would have been issued to the insured.
9. The insurer can call for proof of age at any time if he is entitled to do so and no policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof of age of life insured. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.

Annexure III

Section 38 - Assignment and Transfer of Insurance Policies

Assignment or transfer of a policy should be in accordance with Section 38 of the Insurance Act, 1938 as amended by Insurance Laws (Amendment) Act, 2015 dated 23.03.2015. The extant provisions in this regard are as follows:

01. This policy may be transferred/assigned, wholly or in part, with or without consideration.
02. An Assignment may be effected in a policy by an endorsement upon the policy itself or by a separate instrument under notice to the Insurer.
03. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made.
04. The assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness.
05. The transfer of assignment shall not be operative as against an insurer until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy thereof certified to be correct by both transferor and transferee or their duly authorised agents have been delivered to the insurer.
06. Fee to be paid for assignment or transfer can be specified by the Authority through Regulations.
07. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the insurer of duly receiving the notice.
08. If the insurer maintains one or more places of business, such notices shall be delivered only at the place where the policy is being serviced.
09. The insurer may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is
 - a. not bonafide or
 - b. not in the interest of the policyholder or
 - c. not in public interest or
 - d. is for the purpose of trading of the insurance policy.
10. Before refusing to act upon endorsement, the Insurer should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of policyholder giving a notice of transfer or assignment.
11. In case of refusal to act upon the endorsement by the Insurer, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Insurer.
12. The priority of claims of persons interested in an insurance policy would depend on the date on which the notices of assignment or transfer is delivered to the insurer; where there are more than one instruments of transfer or assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to Authority.
13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except

- a. where assignment or transfer is subject to terms and conditions of transfer or assignment OR
- b. where the transfer or assignment is made upon condition that
 - i. the proceeds under the policy shall become payable to policyholder or nominee(s) in the event of assignee or transferee dying before the insured OR
 - ii. the insured surviving the term of the policy

Such conditional assignee will not be entitled to obtain a loan on policy or surrender the policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.

14. In other cases, the insurer shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such person

- a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment and
- b. may institute any proceedings in relation to the policy
- c. obtain loan under the policy or surrender the policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings

15. Any rights and remedies of an assignee or transferee of a life insurance policy under an assignment or transfer effected before commencement of the Insurance Laws (Amendment) Act, 2015 shall not be affected by this section.
